STAFF REPORTS:

Shelly Cassaro – Deputy Director of Finance and Administration presented the following:

• January monthly financials were reviewed at the PFC meeting last week. As discussed, it was an extraordinary month for snow removal but other than that the budget is on track. We also presented the Tentative FYE2025 budget of which we are looking for a motion for approval tonight. It will then be publicly posted for 30 days and will be brought to you in April. It is a balanced budget, and we are increasing operating revenue by almost 5% and operating expenses by a little more than 5% with a 32-million-dollar capital budget of which 23 million is federal funding.

Michael Peranich – Director of Operations and Maintenance presented the following PowerPoint presentation:

- Visit from several representatives from Federal Aviation Administration (FAA), including Debra Bartell. The main point of the meeting was to discuss the Airport Master Plan including the Airport Layout Plan (ALP), the Transportation Improvement Plan (TIPS), and discuss funding options. It was a very successful tour of the new private companies located at RFD as well.
- Demolition of the old UPS employment office is underway.

Zachary Oakley – Executive Director, reported the following:

- Announcement of LAX on Allegiant to begin June 12. Head of network planning at Allegiant commented on a local news story regarding the partnership between RFD and Allegiant.
- Cargo CMA/CGM, we're still in the game. Peter Wier, CEO of Menzies has been instrumental in coordinating efforts on behalf of RFD. We are hoping to hear of their decision in the next two or three weeks. Menzies will be handling cargo in mid-March. There is a meeting tomorrow with Emery to discuss the transition.
