RESOLUTIONS & ORDINANCES:

Commissioner Schablaske motioned to approve **Ordinance #23-01** adopting the Budget and Appropriation Ordinance for fiscal year beginning May 1, 2023, and ending April 30, 2024. The motion was seconded by Commissioner Myers and was unanimously approved.



Commissioner Schablaske motioned to approve **Resolution #23-22** approving a Purchase Order for one Graco Self Propelled Gas Hydraulic Airless Line Striper from Sherwin Industries of Milwaukee, WI.
