Carrie Zethmayr of Zethmayr, Inc. presented an update and overview of the status of the Foreign Trade Zone program.

Michael Peranich, Director of Operations and Maintenance, reported the following:

• The Taxiway P project should be complete by the end of October.

- RFD staff took part in the United Airlines disaster drill this week.
- We will be holding the second annual Snow Dog Rodeo next month from 11-3 pm.
- Airfield closure plan for this month will have minimal impact on tenant operations.
- Airfield painting is taking place and should be completed in the next two weeks.
- We have held 24 airfield tours for different schools and organizations to date with a total of 42 planned for the calendar year.

Zachary Oakley – Executive Director, reported the following:

- We have received good news coverage (16 articles) of the Pharma flights at RFD last month.
- Staff will be attending the Allegiant conference next week.
- Our FAA cargo ranking numbers have been released. RFD is now #15 largest cargo airport
 according to landed weight. There are three other airports with a few million pounds of each

Commissioner Castanza motion to approve **Resolution #24-63** to award the contract for the reconstruction of Taxiway F to Plote Construction, Inc. of Hoffman Estates, IL.
