## **RESOLUTIONS & ORDINANCES:**

Commissioner Schablaske motioned to approve **Resolution #23-24** approving a corporate name change for FTZ operator Mitsubishi Logisnext Americas (Marengo) Inc. changed to Mitsubishi Logisnext Americas Inc. The motion was seconded by Commissioner Agnew and passed unanimously.

Commissioner Schablaske motioned to approve **Resolution #23-25** approving a Minor Boundary Modification Application for FTZ usage-driven site status on behalf of Capitol Warehousing Corporation, Belvidere, IL. The motion was seconded by Commissioner Agnew and passed unanimously.

Commissioner Schablaske motioned to approve **Resolution #23-26** approving a Purchase Order for one Altoz Zero Turn TRX 766 Lawn Mower with Stripe Kit and Side Chute Shut off, from CGM Sales of Monroe, Wisconsin. This is a Sourcewell GPO purchase, amount is \$22,650.00. The motion was seconded by Commissioner Agnew and passed unanimously.

Commissioner Schablaske motioned to approve **Resolution #23-27** approving a contract for Surface Pavement Repairs with Sjostrom and Sons, Inc. of Rockford, IL, as a result of Invitation to Bid 23-06. The Contract will start on August 1, 2023, for a 3-year period with two one-year options available. The spend amount will depend on the need for these repairs, budgeted amount for FY24 is \$500,000. The motion was seconded by Commissioner Agnew and passed unanimously.

Commissioner Schablaske motioned to approve **Resolution #23-28** approving the new Slate of Officers for the Board of Commissioners effective May 1, 2023, through April 30, 2024. The motion was seconded by Commissioner Agnew and passed unanimously.
